AUDIT SUMMARY

Results in brief

In the areas we audited, College operations complied with applicable requirements and provided adequate safeguarding of public resources. The College also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Clover Park Technical College from July 1, 2012 through June 30, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the College's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Local funds
- Financial aid (Pell grants)

- Payroll
- Travel

RELATED REPORTS

Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Comprehensive Annual Financial Report (CAFR) prepared by and available from the Office of Financial Management.

The CAFR reflects the financial activities of all funds, organizations, institutions, agencies, departments and offices that are part of the state's reporting entity. That report is issued by the Office of Financial Management in December of each year and can be found at www.ofm.wa.gov.

Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

INFORMATION ABOUT THE COLLEGE

Clover Park Technical College was founded in 1942 and is accredited by the Northwest Association of Schools and Colleges. It is among 34 community and technical colleges in the state. Located in Lakewood, it serves approximately 7,200 students a year with a staff of approximately 350. The College had a general operating budget of \$28.7 million for fiscal year 2015-2016. Of that amount, \$18.1 million was derived from state general fund appropriations and \$10.6 million came from local sources and tuition. Expenditures for the College mainly consist of salaries and benefits (82 percent).

The College is governed by a five-member Board of Trustees. Board Members are appointed by the Governor and approved by the Senate. The day-to-day operations are delegated to a Board appointed President.
