In 1991, Kevin Magera was convicted of Assault in the 4th Degree with Sexual Motivation in King County Juvenile Court. In 1993, Magera was convicted of Indecent Exposure in King County Juvenile Court. In March of 2000, Magera was convicted of Rape of a Child in the 1st Degree and Child Molestation in the 1st Degree in Snohomish County Superior Court. According to official documents, Magera (age 22) sexually assaulted a minor female acquaintance (age 5-6) on multiple occasions while babysitting her. Magera pled guilty and was sentenced to 130 months in confinement. In May of 2000, Magera was convicted of Child Molestation in the 1st Degree in Snohomish County Superior Court. According to official documents, Magera (age 22) sexually assaulted a 6-year-old male acquaintance. Magera pled guilty and was sentenced to 130 months in confinement. In 2013, Magera was found to be a Sexually Violent Predator (SVP) and civilly committed at the Special Commitment Center (SCC) on McNeil Island. Magera participated in the sex offender treatment program while at the SCC. In 2019, Magera was found eligible to release from the SCC to a less restrictive alternative (LRA) placement in the community. Due to his sexual criminal history, Magera has been classified a Level 3 sex offender.

*Sex offender laws allow for the tracking of offenders. The laws do not control the location of where and offender chooses to live or where they choose to obtain education.*

*In Washington state there are over 20,000 convicted sex offenders eligible for registration. There are currently over 2,600 registered sex offenders in Pierce County.*
